## Course description

The purpose of this course is to provide undergraduate students with a general background in astronomy. Course content includes: the history of astronomy, the solar system, extrasolar planets, stars, galaxies, dark matter, dark energy, and cosmology. A desired outcome of this course is that students will want to read articles in the popular press about advances in astronomy and will do so with understanding and confidence.

## Grading procedure

Grades will be calculated using the following template: (1) two midterm exams – 20% each, (2) homework – 30%, (3) final exam – 30%. Please note that exams will be based on exam reviews, homework, and questions on the lecture viewgraphs.
