### Course Strategy:

This course covers the general content of Chapters 16-23 in Zangwill, including waves in vacuum, simple dielectric matter, and dispersive matter, wave guides, radiation by moving charges, special relativity, and light scattering. Different from Phys 607, you will learn how to solve Maxwell's equations in the most general scenario, i.e., including time variant source terms, and an exciting new view of the spacetime.

Reading the sections of the textbook corresponding to the assigned homework exercises is considered part of the homework assignment; you are responsible for material in the assigned reading whether or not it is discussed in the lecture. Homework will be due weekly in Thursday's lecture. Late homework submission is not accepted. Your lowest homework score will be dropped.

Private chatter during lecture is very distracting, but it is perfectly OK to interrupt the lecture by yelling "Question!" Questions in lecture are always good, and are strongly encouraged! I encourage collaboration, an essential skill in science and engineering. However, it is also important that you OWN the material. I strongly suggest you start homework by yourself (and that means really making an extended effort on every problem) Then work with a group, and finally, finish up on your own - write up your own work, in your own way.

There will be various topics that you choose and do research on. You will write a term paper on the subjects and give a presentation on the subject. The duration of the presentation will be 20 minutes following a Q&A session. Your presentation will be judged by both your peers and professor. Your term paper will be graded by the professor solely, with the rubrics provided.

Sept 9: Topics selected.

Sept. 23: Outlines of the paper due, with a number of minimal references.

Nov. 4: Draft paper due.

Dec. 2: Final paper due.

Presentation: Dec. 2 - Dec.11 (actual date may fluctuate, depending on course progression).
